LABOUR MP FOR SITTINGBOURNE AND SHEPPEY JOINS NEW LABOUR GROUP IN PARLIAMENT STANDING UP FOR COASTAL COMMUNITIES

The MP for Sittingbourne and Sheppey has joined a new group of Labour MPs representing coastal seats who are pushing the government to take strong action to support coastal communities.

MP Kevin Mckenna said he was joining the group to ensure the voice of coastal communities like Sittingbourne and Sheppey was being heard loud and clear in government.

The group is being chaired by Polly Billington MP, one of a large number of new Labour MPs that took coastal seats off the Conservatives at the 2024 general election. Labour now has 66 MPs representing coastal parts of the country, including many in Kent, meaning the group will have a strong voice in parliament when it comes to championing coastal towns.

After fourteen years under the Conservatives many coastal areas suffer from above average levels of deprivation and poorer health and educational attainment. The group say struggling economies and the terrible state of public services in these areas was the biggest reasons voters turned away from the Conservatives at the 2024 general election, and that the new government needed to prove it could turn that situation around. They say the key to this is ensuring the government deliver on the commitments they have made to end the crisis in the NHS, fix public transport, tackle crime and antisocial behaviour, and deliver more money in people's pockets.

The MPs have also expressed concern about the negative impact on coastal areas of plans that have been suggested by the Reform UK leader Nigel Farage, such as making people pay for health insurance to access the NHS.

The new group is holding regularly meetings with government ministers to raise issues of high concern to voters in their communities. In particular, the Coastal Labour group are united in pushing hard for investment that will deliver well-managed public services and a stronger economy in the coastal towns they represent.

Chair of the Labour Coastal Group, Polly Billington MP said:

"Voters in seats like mine rejected the Conservatives last year because Labour promised renewal, after fourteen years of Tory indifference to the unique challenges facing coastal towns. Now that we're in government we've got to prove to people that we can deliver on key issues like the NHS, tackling crime, and building a stronger economy.

"That is why I am pleased to be chairing this new coastal grouping of Labour MPs, who will make sure that the voices of coastal areas across the country have their voices heard in government."


MP Kevin McKenna said:

NEWS FROM CITIZENS ADVICE SWALE

A re you struggling to pay your council tax bill? It is a difficult time for people who are battling rising costs for food and essentials - as well as seeing their bills creep up.

There is support available and you might be entitled to pay less, or not at all, depending on your circumstances. For example, if you are the only adult living in your home, your council tax bill can be reduced by a quarter. When the council works out how many people live in a property, there are certain 'disregarded' people that do not count and this can reduce your council tax bill, such as under-18s, full-time students and people with severe mental impairments. If you or someone you live with is disabled and your home has been adapted, you can ask to be placed down one band.

Swale Borough Council also offers Council Tax Support, which is designed for people on low incomes, and can reduce the amount of council tax you have to pay. And lastly, if you are struggling to pay for essentials, your council can reduce your bill further, or cancel it altogether, under what is known as a 'discretionary reduction.' This usually only happens if you can provide evidence that you are suffering severe hardship and can't afford to pay council tax.

Whatever circumstances you are in, if you are struggling with your council tax payments, it is important to let your council know. Citizens Advice Swale is also here to help you find a way forward, should you need our support.

Dear Friends

on the 20th of April we celebrate Easter Sunday, the high spot of the Church calendar. It's when we celebrate the resurrection of Jesus Christ. Arriving at Easter Sunday, we must first get through Good Friday, the day when Jesus was crucified.

St. Michael & All Angels' Church Hartlip has many interesting stained-glass windows. On opposing sides of the nave, you can find two triptychs. The north series show important scenes from the life of Jesus: his conception, baptism, and resurrection. On the south side, the series of windows show the crucifixion. The left-hand panel shows Mary, the mother of Jesus, with Mary Magdalene; and on the right are his disciples Peter and John. All are focussed on the dying Jesus. As onlookers, we are witnesses to this terrible event. In the central section of the crucifixion triptych, the picture is divided horizontally into two parts. Above is a blue sky with a sun and a moon. Below that, is an apple tree bearing many apples, representing the temptation of Eve and the introduction of evil into the world. This crucifixion image may be demonstrating the evil within mankind has fastened Jesus, God amongst us, to the cross and killed him.

As an onlooker, we can choose to turn and walk away, or to turn and realise that the Way of Jesus, a way of living based on love and compassion, forgiveness, inclusion, peace, and generosity, is how we will find fulfilment in life. And we can choose to walk that path. Walking that path of life, is what the resurrection section of the triptych on the north wall is all about. See? The apparently thin and dried up tree in the picture is flowering. Mary, Mary, quite contrary, how does your garden grow?

BREAKFAST BLITZ

On a bright March morning 13 members of Iwade Men's Breakfast Club assembled at The Blitz Café prior to our tour of Eastchurch Aviation Museum and the Sheppey Honey Workshop next door.

The guided tour of the museum started with an introductory film explaining the history of the site where the first recognised flight by a British pilot in Britain took place in 1909. The site was home of the Royal Navy Flying School in 1911 which developed into the Royal Air Force in 1918. The Short brothers also manufactured planes here (before moving to Rochester) and at one time over 3,000 were employed on the site. The RAF closed the site in 1946 and the Prison Service then started to develop the site into the complex it is today. Next door at Sheppey Honey the explanation given by Derrick of the life cycle of Bees and how Honey is made was fascinating (did you know it is estimated the bees have to fly 3.3 million miles to make a kilo of honey!) We would not only like to say thank you to the team who looked after us during out visit but recommend a visit to anyone interested as its only a 20-minute drive from Iwade and admission is only £2 and children under 16 are free.

The Chair welcomed everyone to the meeting. Apologies receveived and accepted from Cllrs. D. Waters and S. Waters.

2) Declarations of Interest and Dispensations: None.

3) Minutes of the Previous Meeting

Proposed by Cllr. Holowczycki and seconded by Cllr. Hartley, the minutes of the monthly Parish Council Meeting held on 8 January 2025 were agreed and signed by the Chair as a true record.

4) Visitors/Public Time

- 1. Visitors: A member of the allotments association spoke to the council about the Raspberry Hill community benefit fund. Council members agreed to support their application for CCTV. Cllr. Tolhurst spoke on behalf of a resident concerned about the safety of pedestrian access at the A249 roadworks. The Clerk will contact Jackson Civil Engineering. Action: Clerk
- 2. County and Borough Councillors: Cllr. Baldock advised Kent County Council (KCC) will hold their budget meeting on Thursday 13 February. The biggest affect from the budget to Iwade will be cuts to the Highways budget. There is not enough money to carry out the maintenance needed to Kents Highways. Also, the cutting of Community Wardens who are valuable resources.

Swale Borough Council are also due to hold their budget meeting. Labour have proposed the budget should cut members grants and cancel the loneliness project. A group of councillors met to propose the budget cuts are restored.

Local Heritage Listing will be reviewed again this year and Cllr. Baldock encouraged council members to draw up a list and submit it to Swale. For example, old Victorian letter boxes in walls.

The local plan for the Highstead development was called in by the secretary of state. Full information was not provided to council members to make a decision. It is concerning that this decision is by-passing local democracy.
