Dear Friends

Gloom, doom, despair and despondency. Does that seem a fair description of how a glance at our world might seem right now? As I write, deep in January, the weather is gloomy, the sparkle of Christmas has passed, many people are suffering from flu and viruses, war continues to rage in Ukraine and the best the news has managed this week is that the UK isn't actually in recession because so much beer was drunk during the World Cup. Not exactly cheering, or a source for great optimism!

So, is it time to withdraw, wringing our hands at the hopelessness of it all, and accepting there is no hope? I don't think so. In the midst of the darkness there are many signs of hope; it's just that sometimes we need to look for them!

The climate crisis is, quite frankly, terrifying in its intensity and implications for so many people, even now. And yet there are glimmers of hope. The hole in the ozone layer, which posed such a threat throughout the 1980s, has been gradually repairing, and is likely to be largely recovered by 2040, thanks to the 1989 Montreal Protocol, an international agreement which helped eliminate 99% of ozone-depleting chemicals. A remarkable, and widely unnoticed, result, which must bring hope. A serious threat was internationally recognised, action was taken, and the result is of immense importance to the whole of humanity. And surely, if that can be done in this area, there is hope for other threats facing our planet.

During 2022, more than a quarter of the UK's grid electricity came from wind power; in one day on late December, more than half the electricity was wind-powered. Technology around renewable energy is exciting and fast-moving, a real source of hope.

Our precious NHS is facing appalling pressures, but in the field of healthcare the advances are astonishing, with major breakthroughs in the treatment of Alzheimer's and cancer announced in recent months.

There is no reason for us to become mired in hopelessness; there are signs of hope. And somehow these make me feel it is worth making a fuss to protect and rebuild those areas of life where the pressures are so damaging, such as the state of the NHS and other public services, and our environment.

And of course, we have the hope that came into the world at Christmas, not in a tinselled, gift-wrapped bauble of sparkly inconsequence, to be packed away once the festivities are over, but as the Son of God, our friend, brother, Saviour and Redeemer, Jesus Christ. Light shining in the darkness. Who calls on us to be light in the darkness.

Welcome and Apologies

The Vice-Chair formally welcomed everyone to the meeting. Apologies were received and accepted from Parish Cllrs. Dollimore and Cheeseman and the PCSO.

Visitors/Public Time

Visitors – Residents attended to see if there had been any update regarding the parking issue in Sheerstone – the Vice-Chair advised nothing to date, but the Council is still pushing for a response from Swale/KCC Councils.

A resident complained about the number of lorries in the village going to and from the Pond Farm site; he was advised Swale Borough Council is dealing with this. The same resident again raised the issue of youth provision in the village. It was agreed to place this on the December agenda.

Action: Clerk

County and Borough Councillors – County Cllr. Baldock advised that at the last Swale West Parishes meeting it was of concern that quite a few Parish Councils are now considered to be inquorate, due to difficulty in filling Parish Councillor vacancies. Highway Improvement Plans were discussed, and Parish Councils are gradually coming on board with this.

Community Warden/PCSO - Neither attended; written report received from PCSO:

Crimes of note:

25/10/2022 – School Mews – Youths have caused criminal damage to the wall in the village square. A crime report has been created after it was reported to police by way of the Parish Clerk.

Anti-social behaviour and other incidents of note:

30/09/2022 – Grovehurst Road – Male approached 16-year-old female asking for directions, which she gave. He then asked her where could charge his phone. When the female's mother arrived to pick her up the male quickly walked in the other direction. Local officer was made aware.

01/10/2022 – Dunlin Walk – Reports of a nuisance bike driving around the area. Officer attended but was unable to locate the vehicle.

03/10/2022 – School Lane – reports of a suspicious male outside the school during the evening when Dance Class is on. Officer aware and will attended the location at Key times.

Adam is also the Community Warden for Iwade and surrounds, he covers five areas and has tried to work out where they can do youth provision. He is now looking for a spot to set this up and is hoping to do so in Iwade. Provision will take place on Wednesday and will start from the 16 January. It will be like a Youth Club, working outside in the summer and inside during the winter. He will contact the Village Hall to see when it can be used for this facility.

Pond Management – Cllrs. Tolhurst and Cheeseman met with David Carey, Chairman of the Kent Tree and Pond Partnership on the 18 December, to look at the pond. It was agreed to speak to Swale Borough Council (Clerk to give contact details to Cllr. Tolhurst); speak to the Environment Agency and consider the wildlife impact. Keep on the Agenda. Action: Cllrs. Tolhurst/Cheeseman/Clerk

Damaged Footpaths Sign – Proposed by Cllr. Whiting and seconded by Cllr. Lancashire: agreed the quote of £285 to replace the uprights on this sign.

Action: Clerk

Replacement of two Hornbeam Trees - Proposed by Cllr. Lancashire and seconded by Cllr. Tolhurst; agreed the quote of £614.40p for 2 x 16/18 root ball Hornbeam Trees, stakes, ties, compost and Delivery. Also accepted the quote of £365 to plant these and the tree in Item 8.2. Action: Clerk

Request for Grant Parent and Toddler Group – Proposed by Cllr. Cheeseman and seconded by Cllr. Lancashire; agreed the grant of £826.50p.

Action: Clerk

Reduction/Cessation of Swale Borough Council Lighting Grant – Clerk advised that Swale Borough Council is cutting the yearly grant from £2620 to £550, which a loss in income. The Borough Council has stated that it will go out to consultation, but no details have been received so far.

Request for Donation – Marie Curie – Proposed by Cllr. Dollimore and seconded by Cllr. Stalley-Moores, agreed the S.137 donation of £50.

Action: Clerk

Grounds Maintenance Contract – Clerk has approached KCC to see if money can be saved by them taking back the contract but adding extra cuts (they normally cut 6 times a year, the Parish Council's present contract is 10+ cuts), however, in the long run the cost exceeds that being paid at present.

Streetlights, Electrical and structural testing – possible handing over to KCC – Proposed by Cllr. Lancashire and seconded by Cllr. Langham agreed the quote of £997 to undertake the testing. The Clerk has approached KCC to see if they would adopt the parish lighting (26 columns), but the cost involved in doing this far exceeds the yearly cost to the Parish Council

Reports from Representatives

Hall – Having issues with condensation behind the new ceiling panels.

KALC – AGM - There were two initial addresses by Roger Gough (RG) Leader of Kent County Council and Matthew Scott (MS), Kent Police Commissioner.

RG advised that he had got together with Hampshire County Council who are a similar size to Kent, and they had written to the Government expressing concerns about resources and the £45m hit to KCC with an overspend of £60m expected to rise to £100m next year. The rise in the Council tax increase cap from 3% to 5% announced in the Autumn Statement would help but there were difficult decisions to be made and they were looking to work with groups such as KALC. There would be severe pressure on services such as Wardens. They were committed to zero carbon by 2030 and were making good progress. He advised that Developer contributions were not sufficient. He also advised that Kent spend more on school transport than most other authorities. MS started by advising that Kent were undergoing a large recruitment programme with an extra 195 Police Officers recruited this year. They were undertaking programmes with youngsters in schools to educate them son the role of the police. County lines have reduced from 80 to 40 so although still too high it is moving in the right direction. He acknowledged problems people were experiencing with reporting incidents to 101 and advised that the high vacancy rate with officers dealing with that service was being looked at with a view to improving the service. There are, however, problems with finance. He advised that they were looking to improve village presence and stated that they would be keeping PCSO's. However, subsequent newscast have indicated that their numbers are being reduced. He spoke of a programme that they have launched called Victim Voice. There are problems particularly with women and girls reporting crimes. He stressed that if a crime was in progress, it should be reported using 999. He admitted that the online reporting system, particularly for ASB is cumbersome and is being looked at. Apparently, Kent Police are one of the largest users of Crime Stoppers.

November parish Council minutes, continued.

Tracker – Cllrs Tolhurst and S. Waters – Tracker circulated to everyone. Cllr. S. Waters has been unable to ascertain if this can be uploaded to the Microsoft 365 site, for use as a working document by everyone. Clerk to raise this with our ICT firm. Action: Clerk

Lamp Column Painting – No response from KCC, Clerk to chase. Action: Clerk
